HAVING considered in Council the letter of Your Excellency's Government in the

Deputation for three years of two Professors of the Presidency College, Calcutta, to act as Bursar and Dean, Finance Department, No. 276, dated the 10th September last, I sanction the proposal to depute two Professors of the Presidency College, Calcutta, to act as Bursar and Dean, with local allowances of Rs. 150 and Rs. 100

respectively, as an experimental measure for a period of three years.

We have the honour to address you regarding a proposal submitted by the Government of Bengal to relieve the Principal of the Presidency College, Calcutta, by the delegation of certain duties to subordinate officers. The duties and responsibilities of the Principal have been increased very largely in recent years by the department both of the College and of the University—with whose work he is intimately connected. Consequently some such measure of relief is considered necessary.

2. It will be observed from the correspondence enclosed that the Local Government have already approved the principle of deputing two Professors of the College to assist the Principal in his financial, administrative and disciplinary duties. These officers will be termed Bursar and Dean, and it is proposed to grant them local allowances of Rs. 150 and Rs. 100 a month respectively as remuneration for the performance of additional duties. These proposals are consonance with the views which we expressed in paragraph 2 of our Financial despatch No. 143, dated the 14th May 1914, and, to a certain extent, with those set forth in your predecessor's Public despatch No. 157, dated the 4th September 1914, in connection with the proposal made by the Government of Madras for the conversion of the Principalship of their Presidency College into a separate whole-time appointment. But if, as is possible, your predecessor contemplated that the object in view might be attained by the creation of new and separate appointments rather than of allowances to Professors, we would suggest that the method of decentralization proposed concerns duties, which, though in some sense matters of routine, could not be entrusted to a subordinate clerical agency. We have obtained information regarding the subordinate staff which exists in the College, and are of opinion that the supervision of their duties, which will under this proposal devolve from the Principal upon the Bursar and the Dean, can best be performed by senior and experienced members of the College staff. We accordingly support the proposal and recommend the grant to the officers concerned of the allowances mentioned, which appear to us to be moderate. In view, however, of the completion of the the Public Services Commission report and other considerations, we desire that the proposed arrangement be sanctioned in the first instance as an experimental measure for a period of three years. The Local Government do not appear to have made budget provision in the current year to cover the cost of the expenditure; but as the amount (Rs. 3,000 a year) is small, it can easily be met by re-appropriation.

In continuation of this department memorandum No. 647 T.—G., dated the 8th October 1915, regarding a proposal to relieve the Principal of the Presidency College, Calcutta, by the delegation of certain duties to subordinate officers, I am directed to forward a copy of the correspondence cited in the margin, and to ask that a copy thereof may be communicated to the Principal.

2. I am to say that you should now ask the Principal to submit through you, as soon as may be, detailed proposals, with the names of the Professors whom it is proposed to appoint to be Bursar and Dean respectively, and that you should transmit the same to Government with an expression of your views. Government trust that it may be found possible, in connection with the appointment of a Bursar, to make such administrative arrangements as will relieve the cashier of some of his financial responsibility, and so provide a solution of the difficulty which has been caused by the necessity which has arisen for demanding an enhanced security from that officer.
